**4. Subject: Adoption Of Amendments And Additions To Adopted Building Codes Ordinance (640.04)**

Recommendation: That Council adopt, by reading of title only, An Ordinance of the Council of the City of Santa Barbara Amending Chapter 22.04 of Title 22 of the Santa Barbara Municipal Code Concerning Local Amendments to the California Building Code and California Plumbing Code, and Revising References to the Uniform Building Code in the Code to Refer to the California Building Code.

**5. Subject: Tactical Patrol Force Program Donation (520.04)**

Recommendation: That Council:

- A. Accept a \$900 grant to the Police Department Tactical Patrol Force Program from the Rotary Club of Santa Barbara North Charitable Foundation; and
- B. Appropriate the funds to the Police Special Operations Account for the Tactical Patrol Force Program.

6. Subject: Appropriation Of Asset Forfeiture Funds For The Purchase Of Ballistic Helmets With Attached Face Shields And To The Santa Barbara Police Activities League (520.04)

Recommendation: That Council:

- A Appropriate \$46,548 in currently available asset forfeiture funds to the Police Special Operations Account to fund the purchase of new ballistic helmets with attached face shields; and
- B Appropriate \$20,000 in currently available asset forfeiture funds to the Santa Barbara Police Activities League, a California non-profit, to fund after school programs on the campuses of local junior high schools.

7. Subject: Increase Change Order Authority To Use FAA Grant And Passenger Facility Charges Funds For The Santa Barbara Airport South Apron Rehabilitation Project (560.04)

Recommendation: That Council approve additional change order expenditure authority for the Santa Barbara Airport South Apron Rehabilitation Project (Project), Contract No. 22,522, in the amount of \$250,000, for a total project expenditure authority of \$1,917,214.

9. Subject: Set A Date For Public Hearing Regarding Appeal Of Planning Commission Approval For 1298 Coast Village Road

Recommendation: That Council:

Set the date of July 15, 2008, at 2:00 p.m. for hearing the appeals filed by 1) Save Coast Village Road, 2) John and Sandy Wallace, 3) Delfina Mott and 4) Friends of Outer State Street of the Planning Commission approval of an application for property owned by Olive Oil and Gas LP and located at 1298 Coast Village Road, Assessor's Parcel Number 009-230-043, Limited Commercial (C-1) and Two-Family (R-2) Zones, General Plan Designation: General Commercial. The project proposes demolition of an existing gas station with two repair bays and construction of a new mixed use building comprised of eight residential condominiums and approximately 5,000 square feet of ground floor commercial space; and
- B. Set the date of July 14, 2008, at 1:30 p.m. for a site visit to the property located at 1298 Coast Village Road.
