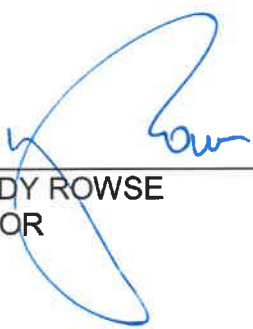
ADJOURNMENT
