Discussion:

Airport Department Staff presented the department's proposed Fiscal Year 2010 budget, which was developed with the goal to maintain the Department's ability to finance the Airline Terminal Project. Adjustments to offset a projected revenue shortfall include a parking fee increase, non-personnel cost reductions, and two staffing changes. Staff also discussed capital projects to be undertaken during the next fiscal year.

Waterfront Department Staff outlined the department's proposed budget for Fiscal Year 2010, which includes reductions to operating expenses and Capital Program funding as well as increases to parking and slip fees. Included in the discussion was a proposed shift to the Waterfront Department of costs for items historically absorbed by the Parks and Recreation Department.

Discussion:

Finance Department Staff explained that the department's budget comprises three funds: the General Fund, the Solid Waste Fund, and the Self-Insurance Fund. Achieving the goal to meet the department's share of declines in General Fund revenues in Fiscal Year 2010 includes the elimination of two vacant positions and the Contracted Revenue Audit Program, and the imposition of a late penalty on delinquent utility accounts. The proposed budget for the Solid Waste Program was then presented, and Staff described in detail the issue of recycling revenues, key projects and initiatives being undertaken by the program, and proposed and anticipated changes in rates charged for solid waste collection. The proposed budget for the Self-Insurance Fund was outlined. Finally, Staff presented the budget for Non-Departmental programs, including recommended reductions to funding allocations made to Community Promotion events. Councilmembers' questions were answered.

By consensus, the public hearing was continued to June 2, 2009, at 9:30 a.m.
